## NOTICE OF RACE

The RRS, the Prescriptions of US Sailing, the Sailing Instructions and this Notice of Race, shall govern this regatta.

Three races shall be run. There are no throw-outs.

Entry is open to yachts eligible to race in the Sydney 38, 1D35, Beneteau 40.7, Beneteau 36.7 and J105 one design classes. Entry fee is \$40.00 if postmarked by Monday, June 12<sup>th</sup>, or \$50.00 if postmarked after the 12<sup>th</sup>. Competitors may enter by turning their entry form and fee to the Sausalito Yacht Club at: Sausalito Yacht Club, Attn: J Rigler, P.O. Box 267, Sausalito, CA 94966 or by Faxing it to 415-332-9058.

The racing venue will be the Knox/Yellow Bluff area. Venue may be changed depending upon weather conditions. Temporary marks shall be used.

Warning gun for race 1 shall be at 1200 hrs.

Sailing Instructions will be emailed no later than Thursday, June 15<sup>th</sup> to all entries received by that time and will be posted on the SYC website no later than 2000 hrs on the 15<sup>th</sup>. Printed copies will be available at the club by 1200 hrs on Friday the 16<sup>th</sup>.

Results will be posted at SYC and will be emailed to all entrants providing email addresses.
