### **Sausalito One Design Invitational Saturday, June 25, 2005 NOTICE OF RACE**

#### **1. RULES:**

The current RRS, the Prescriptions of US Sailing, the Sailing Instructions and this Notice of Race, shall govern this regatta. This regatta is designated Category A.

The low point scoring system RRS A4 shall be used. Three races are scheduled. There are no throw-outs. The rules of J/105 Fleet One will be in effect.

#### **2. ELIGIBILITY AND ENTRY**

The regatta is open to all members of a J/105 Fleet, 1-D 35, Express 27.

**2.1 ENTRY FEE:** The entry fee is \$35 for members of US SAILING and \$40 for non-members, if received by June 25, 2005.

#### **5. RACING AREA AND COURSES**

The racing area will be in the vicinity of the Knox/Yellow Bluff/Alcatraz area. The courses will be described in the sailing instructions.

#### **6. COMMUNICATIONS**

The Race Committee may use VHF channel 66 to communicate information about the races.

#### **7. SCORING**

Three (3) races are scheduled, of which one (1) must be completed to constitute a series. All races will count toward the final score.

#### **8. DOCKAGE**

The SYC guest dock and moorings will be available with shuttle to dock.

#### **9. TROPHIES**

Trophies will be awarded to the top three boats in the regatta.

The trophy presentation will be held on the SYC deck after the racing on Saturday.
