NOTICE OF RACE

RULES

The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS), except as any of these are altered by the Sailing Instructions, the J/105 Fleet One class rules, and by the Sailing Instructions.

ELIGIBILITY AND ENTRY

Invited fleets are 1D35, Beneteau 40.7, Beneteau 36.7 and J/105.

Eligible boats may enter by completing the attached form and sending it to the Tiburon Yacht Club race committee by July 7th, 2006. Forms may be found on the web site or requested by e-mail by contacting the TYC Race Chair at pando@sonic.net

FEES

Entry fee is \$40

SCHEDULE

There will be no formal registration; skippers are required to declare themselves to the Race Committee on VHS channel 71 at least 15 minutes before the start of the first race.

Three races will be held and the Warning Signal for the first race is scheduled for 11:30am. Races 2 and 3 will follow as soon as practicable after the end of the previous race. There will not be a Sailors' Meeting.

All competitors and their guests are invited to attend a social at the TYC after racing. There will be a no-host bar and BBQ will be available for \$10.00 per person.

SAILING INSTRUCTIONS

The Sailing Instructions will be available at TYC on Saturday, July 8th, 2006, or may be downloaded from the TYC website

RACING AREA

Racing will take place East of Paradise Cay around temporary racing marks.

SCORING

The Low Point Scoring System, Appendix A of the Racing Rules, will apply.

One race will constitute a series.

Three races are scheduled in the series, all of which shall count towards a boats final score.

BERTHING

TYC will assist in berthing arrangements for those wishing to leave their boats overnight. Check the TYC web site www.tyc.org (Race Page – TYC Invitational) for people to contact for assistance.
