NOTICE OF RACE

RegattaPRO, a member of the United States Sailing Association, organizes this series.

The RRS, the Prescriptions of US Sailing, Class Rules, the Sailing Instructions and this Notice of Race, shall govern this series.

This regatta is designed as a practice series focusing on starts. Our attempt is to get in at least 10 short races in one day. Courses will be very short, up to the weather mark and down to finish, allowing you to focus on your starts. While these races are intended for practice, we will be expecting participants to take each start seriously. As such, there will be penalties (stated in the SI's) for exceeding the aggregate allowable OCS's, etc., so that everyone receives the maximum benefit of the day.

Coach boats are allowed, but are expected to stay out of the way of racing boats and be cautious of their wake and wind shadow. Support boats not adhering to these rules will be asked to leave the course.

The intended venue will be the South Hampton/Berkeley Circle area. The committee boat will be on VHF channel 63. The Warning Gun for the first race will be at 1130 hrs.

The low point scoring system RRS A4 shall be used. A minimum of one race shall be completed to constitute a series. There will be no throw-outs.

Entry is open to all 1D35 and J105 yachts that are a member of their class association. Entry fee is \$40.00 if received no later than April 16, 2007. Entries received after April 16th will incur a \$10.00 late fee.
